Val Anderson, Attorney from Municipal Law & Litigation Group, S.C. was present at the Board's Request to discuss the following:

- Road Abandonment (School, Myra Lane, Pester Lane, Hyse Lane, Hartman, Jacobson Roads all could be abandoned)
  - o Need to find out how the road was acquired, dedicate, vacate, resolutions, notices and meetings would need to be held. Cannot abandon if it creates land locked.
- Referendum- To raise funds, Fire/Ambulance Contract costs put on Tax Roll as Special Charges
  - o Resolution by an "in favor" Board. Special meeting, and put on the November ballot. Attorney Anderson will do further investigation and will report back to the Board.
- Weight Limit Ordinance. Howard Rd Truck Traffic Used as by-pass around Whitewater. Propose signage. Propose possible weight limits. Chairman will contact Town of Koshgonong for direction on how to adopt an ordinance. How do we keep Semi's off our roads? Can make all roads Class B, that needs enforcement. Must prove there are alternate routes. Must designate a "Truck Route".
- Dog Ordinance- Specifically Kennel License. Dogs-Ordinance#96-1. Discussion to add kennel license to current ordinance. Clerk's follow up with Attorney Macy. Tabled from May meeting. Attorney Anderson will follow up with Jon Macy and will get back to the town.

Northwest Services – Roads/Brush/Maintenance:

- Cold Spring Road. Excessive Pot Holes in need of repair. Still receiving complaints.
- Clean out culvert on Crestwood
- Straighten up all crooked sign posts

WFD, Inc. – Chief Higgins. Proposed a revised contract. Fire Dept \$30,400.00 and Ambulance \$18,160.00. Calls for Faulty CO Detectors, Faulty Smoke Detectors and Smell Investigations, will be charged at \$500.00 Incident calls were put back to \$900.00. Automatic renewal increase of 12% was also removed. Further discussion in regards to fee collections for the Ambulance were requested. Tabled from April meeting as Chief Higgins did not show up to the meeting.
